Currently, our secondary sports programs are in full swing, and many student organizations have worked enthusiastically to prepare for the new school year and competition season. Our dedicated team of educators has diligently prepared our classrooms, facilities, vehicles, and outdoor areas to welcome our students warmly. The excitement reverberates throughout Sharyland ISD. As your child returns to school on Monday, our hope is for them to feel right at home, easing into new routines. From our halls to our playgrounds, to the fields, buses, and boardrooms, everyone is working together and contributing to a better Sharyland ISD.

A few important reminders:

• **Bus Pickup:** Our buses start their routes promptly at 6:30 AM. For the safety of all students, it's important to remember that campus-assigned barcoded student IDs/bus passes will be required by the second week of school. You can access bus routes <u>HERE</u> and set up your Here Comes the Bus Account <u>HERE</u> to monitor your child's daily bus trips in real time. Please note that for children in Pre-Kindergarten and Kindergarten, an authorized adult must be present to receive them at the bus drop-off point. *If there is no adult present, the child will be returned to their home campus at the end of the bus route for safety reasons.*

- **Meal Application/Income Survey:** We kindly ask that you complete your child's meal application or income survey to verify meal benefit eligibility as soon as possible.
- **Hydration:** Students are encouraged to bring their own water bottles; Water dispensers are available throughout our schools.
- **Tech Devices:** SISD provides all students with a technological device for instruction. Secondary students should ensure their assigned device is charged every day.
- Identification: Students and staff will wear IDs for safety on a daily basis
- **Drop-Off Items:** For security reasons, we will not allow drop-off items at any campus during the school day. This includes backpacks, forgotten items, lunches, food orders, or any form of delivery service. We understand that mishaps can happen, and we will work with your child to resolve them. This minor inconvenience is in place to ensure the safety of all.
- **Visitors:** Legal identification is required for campus entry screening during the school day, known as Raptor. Check with your respective campus for visitor policy as new security procedures take effect.
- **School Procedures:** Please confirm drop-off and pick-up times and procedures specific to your campus. Additionally, allocate extra time in the mornings and during dismissal due to potential delays caused by traffic and road construction.
- **Attendance:** It's important. Communicate with school/teachers about attendance and illness. Attendance matters—every day counts!
- **Report:** Report safety concerns here: <u>Keep Sharyland Safe</u>; Report facility/maintenance concerns here: <u>Keep Sharyland Beautiful</u>.

As your Superintendent, it's both my honor and privilege to extend my profound gratitude to our exceptional staff, students, community, and Board of Trustees. Your trust and unwavering support empower us to **LEAD** and serve this extraordinary district. Thank you for being invaluable partners in education, and for your patience as we collaborate on procedures and routines.

METHOD OF INSTRUCTION

Teachers and students will engage in in-person learning on campus every day of the week, fostering a dynamic and traditional educational environment. Our dedicated educators will be physically present in their classrooms, actively delivering instruction to their assigned courses.

All instruction will occur within the traditional classroom setting on campus, with safety and security measures in place. Students will follow a comprehensive daily schedule, benefiting from face-to-face interaction with their teachers across all classes.

Should any student require additional support, tutoring, or remediation, parents or students can explore the availability and schedules with their respective campuses and instructors.

Furthermore, students will continue to receive personalized instruction and related services as recommended by their support programs.

Attendance Requirements:

- Students must attend classes from Monday to Friday:
 - Elementary: 7:45 AM 3:30 PM
 - Junior High: 8:00 AM 3:59 PM
 - High School: 7:55 AM 4:00 PM
- Students are expected to be present for at least 90% of the scheduled class days.
- Official attendance will be recorded daily at 10:00 AM.
- Elementary students' attendance will be logged once daily, while secondary students' attendance will be tracked for each class as per their schedules.

Please note that truancy laws and standards will be strictly enforced for the 2023-2024 school year.



TECHNOLOGY

Student Device Policy: Empowering Digital Learning

At Sharyland ISD, we've transformed our classrooms by installing cutting-edge wireless networks, enabling a seamless 1-to-1 device initiative.

Here's What You Need To Know

Daily Device Requirement: Students are expected to bring their school-issued device to campus every day. Please ensure it's fully charged with the power adaptor.

Power Access: Fear not, power outlets are readily available.

Student Device Management Procedures

Device Responsibilities: Sharyland ISD is committed to enhancing students' educational journeys by providing every student with a technological device, free of charge. These devices are for student use, with no upfront costs. If a device suffers accidental damage, is lost, or is stolen, fret not - we'll replace it once at no cost. However, the same courtesy will not be applied to a third device. Given the costs, supply chain constraints, and microchip shortages, issuing third and subsequent devices for damage, loss, or theft is unsustainable.

Secondary Campus Device Checkout: For secondary students, in the event of a second device issue, you'll need to check out a device from the library daily. Check out in the morning and return it at the end of the day.

Elementary Device Usage: Elementary students are welcome to use devices, but these should remain in the classroom and cannot be taken home.

We appreciate parental support in emphasizing responsible technology use.

Together, we can make the most of these valuable tools for student education.

Remember: Bring your school-issued device fully charged to school every day.

Charger Etiquette: When disconnecting the charger, please do so with care. Disconnecting the charger by pulling on the cable alone is not recommended.

Tech Resources for Learning: Keep in mind that district technology resources are intended for instructional purposes only.



HEALTH-RELATED SAFETY PROTOCOLS, HEALTH SERVICES & COVID-19 INFORMATION

A Clear Path for a Safe School Year

At Sharyland Independent School District, our Back-to-School Plan is a result of extensive collaboration with both district and community stakeholders. This ongoing process ensures that our plan aligns seamlessly with guidance from respected sources such as the Center for Disease Control, Governor Abbott, The State of Texas, the Texas Education Agency, Texas Health and Human Services, and Hidalgo County.

While the nature of the COVID-19 virus remains unpredictable, it's important to understand that SISD cannot guarantee the complete elimination of COVID-19 exposure risk. However, together, we can actively work to minimize this risk for the benefit of all our students, staff, and community members by adhering to the guidelines laid out in this plan.

To enhance safety, please note that campus visits will only be permitted by appointment.

Our Safety Measures in a Nutshell

Temperature Scanners: All our campuses are equipped with temperature scanners. **Daily Health Monitoring:** We encourage students and staff to monitor their health daily.

We'll continue to follow the latest guidance from local, state, and federal health authorities to ensure student safety. Face masks are readily available to anyone who requests or needs one. As they've been instrumental in mitigating the spread of COVID-19 in our schools and community.

Hand Washing: Proper hand washing and sanitizing are vital. Please practice this at the following times:

- Before leaving home for school
- Upon entry
- Before eating
- Before boarding the bus at the start and end of the day
- After using the restroom
- Whenever hands are soiled

Remember, while hand sanitizer is useful, it's no substitute for good old soap and water.

Classroom Measures:

- Air purifiers are installed in all classrooms.
- Classroom capacity is based on enrollment numbers.
- Both students and staff share the responsibility for classroom cleanliness.
- Staff have access to cleaning products and instructions for use.
- Students may be asked to assist in cleaning their desks.
- Classrooms will be disinfected daily.

Class Transitions: Class transitions may include staggered transitions, traditional transitions, and limited permissions for students leaving class.

Restrooms: We'll limit and stagger student and staff access to facilities when possible. Posters will guide proper hand-washing. Ample cleaning and disinfecting supplies will be available.

Clinic Expectations:

- Students and staff will adhere to protective measures.
- Nursing staff will provide minor first aid training for teachers regarding classroom interventions.
- Health clinic restrooms will be reserved for sick students only.
- Designated areas will cater to well, sick, and isolated students and staff.
- Clinic traffic will be controlled to limit the number of students inside at any given time.
- Nurses will follow SISD Guidelines to determine when a student or staff member should be sent home.
- Health screenings (hearing, vision, spinal) will continue, as will required immunizations.

Medication Administration: Medication doses required in the morning or on the first day should be administered at home.

COVID-19 Information: Parents are requested to promptly report any positive COVID-19 cases, suspected cases, or exposures to the campus nurse. Health Services Staff will inform affected individuals of their return to school/work date. We'll continue to closely follow guidance from the CDC, TEA, TDSHS, and the local Health Department.

COVID-19 GUIDELINES

- All return-to-school dates calculated by campus nurses ONLY and provided to parents/guardians and staff.
- Only nurses or designated personnel may discuss COVID-19-related issues with the student's parents or guardians.

Exposure	to

Known exposures outside of or in the home:

- Parents/guardians should monitor their child and staff should monitor themselves for symptoms of illness up to 10-14 days after exposure to COVID-19
- Students/staff may continue coming to school/work UNLESS they 1) begin to feel sick and experiencing symptoms (See Feeling Sick) OR 2) are confirmed to have COVID-19 illness (See Confirmed Positive COVID-19 Illness)

Feeling sick (Experiencing symptoms)

Fever:

Known or undetermined exposure to COVID-19 illness:

Individuals are sent home for temperatures of 100.0F or higher per Texas Department of

State Health Services

and Sharyland ISD.

Already at school/work and becomes sick during school/work hours:

- · Based on history, symptoms, and the campus nurse's assessment, the student/staff may be sent home and advised to seek medical attention from a Texas-licensed medical provider
- Medical referral form may be provided to parent/guardian or staff via email or pick up
- · Return to school/work:
- o With a medical clearance note from a Texas-licensed medical provider OR
- o After being fever free for 24 hours without using a fever reducer to manage elevated temperatures
- · May also obtain COVID-19 testing (e.g. antigen, respiratory panel) from a Texas laboratory or Texas-licensed medical provider
- o Negative test result= return to school/work

Not at school/work yet and feeling sick:

- · Student/staff should stay home if sick
- Parent/guardian or staff should call the campus nurse to report illness
- Medical referral form may be provided to parent/guardian or staff via email or pick up
- · Return to school/work:
- o With a medical clearance note from a Texas-licensed medical provider OR
- o After being fever free for 24 hours without using a fever reducer to manage elevated temperatures
- May also obtain COVID-19 testing (e.g. antigen, respiratory panel) from a Texas laboratory or Texas-licensed medical provider o Negative test result= return to school/work

Confirmed Positive COVID-19 Illness

For students' attendance documentation purposes, parents/guardians must:

- Report COVID-19 illness to the campus nurse within 3 days of a positive test result or illness confirmation by a Texas-licensed medical provider by:
- o Calling the campus nurse directly OR
- o Completing the Student Online Illness Reporting Form (located on school's website under Quick Links) which documents date and time of reporting (if no response from campus nurse within 24-48 hours [excluding evenings, weekends, holidays], call campus nurse)

If after the
student/staff has
ended isolation, but
COVID-19 symptoms
worsen or fever is
present, restart
isolation. Report to

further guidance.

For staff:

• Report COVID-19 illness to the campus nurse and follow return to work guidance

For both students and staff:

- · Provide the campus nurse with a copy of the positive test result (Texas laboratory or Texas-licensed medical provider) with student's/staff's name and date of test OR photo of positive home test with student's/staff's name and test date written on it
- Stay home 5 full days from positive COVID-19 test date OR date symptoms began (As determined by campus nurse or verified by a Texas-licensed medical provider. Day 0 is test day or when symptoms started and Day 1 is the first full day after being tested or when symptoms started.)
- Return to school/work on Day 6:
- o 1) After 5 full days at home. Return to school date calculated by campus nurse (if more than 2-day difference between symptoms and positive test date, return date will be calculated by test date) OR
- o 2) With a medical clearance note from a Texas-licensed medical provider given to the campus nurse (after 5 full days at home)
- Student/staff:
- o Must be fever free for 24 hours without using a fever reducer to manage elevated temperatures AND
- o Improved or improving symptoms AND
- o Encouraged to wear a mask from Day 6 through Day 10 Remember: Individuals with COVID-19 may continue to be contagious up to 10 days

Disclosure: This is a living, fluid document that is used as a framework to guide decisions about exclusion and readmittance and is not all-inclusive of all factors the Office of Health Services considers for each unique case. The District's guidelines reference local county, state, and federal recommendations. The District monitors the impact and transmission of COVID-19 in the local community and surrounding areas to continually update district guidelines, so they are as restrictive or unbinding as dependent on COVID-19 illness in the schools, district, and community climate to protect the health and safety of Sharyland ISD students, staff, and community.

SCHOOL FACILITIES, SCHOOL SAFETY, AND SECURITY

Designated Entry and Exit Points: At each campus, entry and exit points are thoughtfully designated to promote social distancing and enhance safety. Water fountains, including water refilling stations, are accessible for use.

Auxiliary Staff Vigilance: Throughout the school day, our auxiliary staff pays special attention to common areas, including door handles, high-touch points, sinks, water fountains, printers, copiers, phones, and shared technology and equipment.

School Hardening Efforts: Sharyland ISD has implemented a robust Safety and Security Protocol known as "Concentric Circles of Protection," encompassing fencing, cameras, security, and access control.

Armed Personnel: Every campus boasts armed security or armed school resource officers. **Law Enforcement Partnerships:** We've forged strong partnerships with local law enforcement departments in Mission, McAllen, Palmhurst, Alton, Edinburg, and the Hidalgo County Sheriff's Office. These collaborations facilitate effective communication, especially during crises.

Identification Cards for Everyone: All students, staff, and personnel must visibly display their ID cards while on campus.

Visitors: We welcome parents and other visitors to our district schools. To ensure safety and minimize disruptions during instructional time, visitors must first report to the main office and adhere to district policies and procedures. All visitors will be screened via the Visitor Management System by Raptor Technologies and must provide acceptable forms of identification.

Deliveries to Campus: For the safety of all, we no longer allow deliveries of food, clothing, money, forgotten schoolwork, backpacks, or instruments at SISD campuses. This helps regulate traffic flow and strengthens our school's safety measures.

Required School Safety Action Steps: TEA (Texas Education Agency) mandates safety protocols each school year. SISD conducts Door Safety Audits and will continue to perform periodic Intruder Detection Audits and Safety checks throughout the year.

Standard Safety Protocol (SRP): SISD adheres to the SRP to establish uniform emergency protocols for all our schools, buildings, and facilities. Faculty and staff have received training, and students will be trained once school begins.

Emergency Safety Drills: All campuses and facilities conduct regular emergency safety drills to practice responses to simulated emergency scenarios, involving students, staff, security, and the police department.

Safety Drills: We continue to adhere to state-mandated drills and safety measures at all campuses, including secure, lockdown, evacuate, hazmat shelter, severe weather shelter, and fire drill evacuation drills.

Safety Protocols at Athletic Events: For safety at junior high and high school athletic events, Sharyland ISD has instituted a Clear Bag Policy for all spectators and visitors.

Remember: Safety and security are everyone's responsibility. Partner with us by reporting threats, and suspicious activity, and not spreading false information. We take all threats and reports seriously because keeping Sharyland safe is a collective effort.

Assistant Superintendent's Notice



Parents and Guardians.

We would like to make you aware of a new law concerning the use of vapes in schools that was passed by the 88th Texas Legislature and will be taking effect on September 1, 2023. House Bill 114 (HB 114) has been enacted to respond to the increasing concerns around e-cigarettes, vaping, marijuana, and THC-related products among our youth. House Bill 114 mandates that any student found in possession of, under the influence of, selling, gifting, or delivering these substances within a 300-feet radius of any school premises, will be immediately removed and placed in a Disciplinary Alternative Education Program (DAEP). You can access the full version of the Bill here:

House Bill 114 (HB 114)

We want to emphasize the strict consequences that come with violating this new law. Any student, regardless of age, found in possession, use, or contact with any type of vape (e-cigarette) including whether it contains nicotine or THC, will face these repercussions. Such actions will result in mandatory placement in the Disciplinary Alternative Education Program (DAEP), per law. It is essential to understand the DAEP placement entails being prohibited from accessing our campuses for any reason during the duration of the placement. Additionally, students in DAEP are not allowed to participate in any UIL or extra-curricular activities, including games, practices, dances, ceremonies, concerts, or plays.

As stringent as the measures may seem, we are obliged to adhere to the law and prioritize the safety and well-being of all our students. Our commitment to providing a conducive and secure environment for learning remains our focus. We recognize the significance of preventative education, and as such, we will continue to educate all students on responsible decision-making and begin to reiterate the dangers of vaping with all age-appropriate students.

Please take a moment to discuss the implications of this new law with your children, emphasizing the importance of adhering to school policies and laws for their own welfare and for the betterment of the school community as a whole.

Also, to do our part to reduce vaping in schools, Sharyland ISD has installed vape detectors in our junior high and high school restrooms. These vape sensors will notify the administration in real time when a student vapes in one of our restrooms. It is a tool that not only alerts but assists during the investigation of a vaping incident. We will be consistently monitoring our vape sensors to assist in mitigating the negative impact of vaping in our schools. Our goal is to be proactive and help prevent the use of e-cigarettes among our students as much as possible.

Your cooperation and support in ensuring that Sharyland ISD remains a safe, healthy, and thriving educational environment for our students is deeply appreciated. BUS TRANSPORTATION

We prioritize the safety and well-being of all students using our bus transportation service. From the moment students arrive at their designated bus stop to the time they board the school bus, we encourage strict adherence to safety and sanitizing protocols.

Bus Stop Expectations:

- Students are encouraged to practice social distancing whenever feasible while waiting for and approaching the school bus, provided there is adequate space and safety.
- Sharing food, drinks, or personal devices is strictly prohibited.

Boarding Bus Procedures:

- Students should exhibit good behavior and form a single line as they approach and board the bus.
- As an option, hand sanitizer is available near the bus stairwell.
- Mandatory Student ID: Students must scan their ID cards on and off the bus at all times.

Seating Arrangements:

• To facilitate safety, older students are encouraged to sit towards the back of the bus, allowing younger students to occupy front seats when conditions permit. For instance, siblings and younger students may mix with older students, with younger students seated towards the front.

Bus in Motion Rules:

• Standard Sharyland ISD bus rules apply while the bus is in motion.

Daily Disinfecting Protocol:

- Between each morning and afternoon campus drop-off, our dedicated team of drivers, bus monitors, and staff will diligently spray and wipe down seats and high-touch areas with disinfecting spray.
- Bus seating areas will undergo thorough disinfection after each bus route, with special attention to high-touch surfaces such as bus seats, steering wheels, knobs, and stairway handrails.
- Weather permitting, select bus windows and the roof hatch will be opened to enhance air circulation and ventilation, aiding in the mitigation of COVID-19 spread.



Weekly Deep Disinfecting Process:

• Twice a week, we'll employ electrostatic spraying to comprehensively disinfect the bus interiors.

Parents/Guardians:

- We appreciate your assistance in supervising your children at the bus stop whenever possible.
- Parents are encouraged to download the Here Comes the Bus application or visit the website <u>HERE</u>. Full instructions can be found <u>HERE</u>.

Teacher/Staff:

- Our dedicated staff will supervise student arrival and dismissal.
- Staff members will ensure social distancing, to the extent possible, during arrival and dismissal.
- During dismissal, teachers will supervise designated pre-loading areas for students awaiting the arrival of the bus.



CHILD NUTRITION


Sharyland ISD Child Nutrition strives to offer healthy and nutritious meals every day. We are pleased to announce participation in the Community Eligibility Provision (CEP) at the following campuses starting the 2023-2024 school year: Pioneer High School, Sharyland North Jr. High, Shary Elementary, Garza Elementary, Jensen Elementary, Martinez Elementary, Bentsen Elementary, and Wernecke Elementary. Students attending these campuses are eligible to receive meals at no cost. Households do not have to complete a household application, but your child's campus will ask you to complete an Income Survey.


Students attending Sharyland High School Sharyland Advanced Academic Academy (SA3), BL Gray Jr. High, Hinojosa Elementary, and Shimotsu Elementary may qualify for free or reduced-price meals. Beginning the 2023-2024 school year and through the school year 2024-2025, breakfast for reduced-price eligible students will be available at no cost. Reduced price lunch is \$.40; paid student lunch is \$3.00 for elementary schools and \$3.50 for secondary schools.

During the school day:

- No meal drop off or deliveries are permitted at any campus.
- · Breakfast in Class is available at participating elementary campuses.
